
**NOTICE OF PLAINTIFFS' MOTION FOR CLASS CERTIFICATION

PLEASE TAKE NOTICE that Lead Plaintiffs hereby move this Court pursuant to Fed. R. Civ. P. 23 for an Order: (1) certifying an Aftermarket Purchaser Class, a Rule 23(c)(4)(A) Class, and a Securities Act Class as they are defined in the Memorandum of Law in Support of Plaintiffs' Motion for Class Certification in Six Focus Cases; (2) adopting the proposed class definitions in each case; (3) appointing the proposed class representatives (listed in Exhibit 1) in each of their respective cases as the class representatives for the classes; and (4) appointing the members of the Plaintiffs' Executive Committee as class counsel for the focus cases.
